#### **AFFIDAVIT IN SUPPORT OF THE PETITION**

- 1. <u>**THAT**</u> I am a resident of Mandera North Constituency, Mandera County, well conversant with the facts of this matter and hence competent to swear this Affidavit.
- <u>THAT</u> I was appointed to serve as a Presiding Officer at Guticha Primary School in Mandera North Constituency. Upon appointment, I was trained at Rhamu Arid Zone Primary School and I proceeded to take an oath of Secrecy administered by the Principal Kadhi, Mandera.

- 3. <u>THAT</u> on 7<sup>th</sup> August, 2017 on the eve of elections at around 5.00 pm, we were all called to the Independent Electoral and Boundaries Commission's Office in Mandera North to collect materials so as to report to our respective polling stations.
- 4. <u>THAT</u> I was appointed to serve as a Presiding Officer at Guticha Primary School in Mandera North Constituency. Upon appointment, I was trained at Rhamu Arid Zone Primary School and I proceeded to take an oath of Secrecy administered by the Principal Kadhi, Mandera.
- 5. <u>**THAT**</u> On 7<sup>th</sup> August, 2017, I reported together with other clerks for duty. Upon reaching the place of work a clerk of the Commission informed 70 of us that our names had been replaced by others for unexplained reasons. A protest arose and we reported the matter to Rhamu police station.
- 6. <u>**THAT**</u> The following day, 8/8/2017, elections proceeded at various polling station conducted by strangers who were acting as presiding officers, but who had not been trained and had not taken oath of secrecy.
- 7. <u>**THAT**</u> this opened voter numbers to alteration at the Constituency Tallying Centre which was moved to Sub County Commisioners office boardroom against a court order which had directed that the tallying centre should be at Rhamu Arid Zone Primary School.
- 8. <u>**THAT**</u> this kind of rigging happened throughout Mandera County.
- 9. <u>**THAT**</u> I now annex hereto and mark ""IMI" documents supporting the above.
- 10. <u>**THAT**</u> I swear this Affidavit in support of the Petition and humbly seek this Honourable Court's intervention allow this Petition and secure our democracy.
- 11. <u>**THAT**</u> what is deponed to herein is true to the best of my knowledge and in accordance with the Oaths and Statutory Declarations Act, Chapter 15 of the Laws of Kenya.
