- 1. **THAT** I am a resident of Mandera North Constituency, Mandera County, well conversant with the facts of this matter and hence competent to swear this Affidavit.
- 2. **THAT** I was appointed to serve as a Presiding Officer at Kalicha Primary School in Mandera North Constituency. Upon appointment, I was trained at Rhamu Arid Zone Primary School and I proceeded to take an oath of Secrecy administered by the Principal Kadhi, Mandera.
- 3. **THAT** on 7th August, 2017 on the eve of elections at around 5.00 pm, we were all called to the Independent Electoral and

- Boundaries Commission's Office in Mandera North to collect materials so as to report to our respective polling stations.
- 4. **THAT** upon reaching the place of work a clerk of the Commission informed 70 of us that our names had been replaced by others for unexplained reasons. A protest arose and we reported the matter to Rhamu police station.
- 5. **THAT** the following day, 8/8/2017, elections proceeded at various polling station conducted by strangers who were acting as presiding officers, but who had not been trained and had not taken oath of secrecy.
- 6. **THAT** at Kalicha Primary School, polling station 2 of 2 polling stations, all registered voters numbering 594 are all alleged to have voted 100%. In truth, these figures were just filled in at the Tallying Centre.
- 7. **THAT** vote tallies across the Constituency were done at the Sub County Commissioners Block against a court order which had directed that the tallying centre should be at Rhamu Arid Zone Primary School.
- 8. **THAT** this kind of rigging happened throughout Mandera County.
- 9. **THAT** I now annex hereto and mark ""**MNB**" documents supporting the above.
- 10. **THAT** I swear this Affidavit in support of the Petition and humbly seek this Honourable Court's intervention allow this Petition and secure our democracy.
