HIGH LEVEL CORRUPTION IN KAKAMEGA COUNTY GOVERNMENT. (TOP SECRET)

As workers of the County Government of Kakamega with little faith that our concerns will be addressed by your office, do wish to bring to your attention the tragic situation.

There is high level corruption happening every single day occasioned by Governor Fernandes Barasa, Chief Officer for Finance Jeophita June Mwajuma and Chief Officer medical services Dr. David Anekeya Alila

We are sorry to say that we have little faith in your institution but that's the truth of the matter.

We have bad experience with virtually all investigative agencies. Virtually all of them have reported to and made aware our situation worse by converting the bad situation but so far no action taken yet the problems keep mounting and now workers are longer sure of being paid.

Several reports have been made to the EACC office in Bungoma but all the officers do is to come and take tea with the Governor and the RAF the matter goes silent.

At the head office

Former CEO Twalib Mbarak was a personal friend to Chief Officer June Mwajuma with whom were frequently seen together in Dubai, Lamu, and Mombasa.

In fact, we have reasons to believe that he is the reason no case has been preferred against Governor Barasa despite unprecedented impunity and high-level corruption happening in Kakamega County as we write this letter.

Mr. Chairman, the following are open areas of interest that were brought to the attention of your institution without help;

While the National government has been prompt in remission of its obligation to the County government of Kakamega, the county is virtually on its knees.

There are no drugs in hospitals, no fuel, insurance, allowances and the medical cover recently purchased is suspect because hospitals keep rejecting the MTIBA thing.

No tangible projects can be seen happening and those ongoing are not paid for.

It's our humble appeal that the EACC assigns a different set of officers or commissions a multiagency team of investigators to urgently commence investigations into the following areas;

(i) Investigate why county pension fund (CPF) deductions from workers are not remitted the whole of year 2024 despite being deducted from workers' pay slips!

(ii) Investigate similarly, why statutory deductions including workers bank loans, Sacco loans, insurance policies among other deductions being deducted from workers monthly and not being remitted!

(iii) Investigate why the County Government chose to procure medical insurance for workers through a broker this year yet they had purchased directly from Jubilee Insurance last year.

The worrying part is that workers' seeking treatment from hospitals for instance Aga Khan hospital rarely get approvals done.

(iv) Investigate excess disbursement of AIE funds to level four hospitals is usually done in excess and medical officers in charge of the facilities, are advised withdraw the excess and return the Money to the Chief Officer Dr. Alila David. For instance, last year Kshs.10,000,000.00 (ten million) Kshs.10,000,000.00 (ten million) and Kshs.6.000.000 (six million) was withdrawn from Malava, Butere and Iguhu hospital respectively, the same was handed to Dr. Ailah David on 20th October, 2024. The excess funds are always above the Budgets presented by various Boards of those hospitals. After the hospital board has prepared a budget, another secret budget normally prepared by only the medical officer in charge and the accountant is presented and paid! The medical officers in charge of these hospitals in turn were each rewarded with 10% of the amount withdrawn from each respective hospital.

(v) Investigate the centralization of all county government payments through the Chief Officer finance. Other accounting officers have no power to do so; it is like the whole county has one accounting officer the chief officer for finance, a clear arrangement to swindle public funds!

(vi) The Chief officer Finance runs a private office at Kenfiko estate in Kakamega where cooked paperwork and figures of all Ghost projects spearheaded by Deputy Head of supply Chain Management in Kakamega and who lives in Governor Barasa's home. This office is majorly operated by an accountant called Silvester Amurono and Chief officer finance Jeophita Mwajuma whose numbers are 0726237930 and 0722247462/0704490464 respectively.

A complete example of conflict of interest and abuse of office. The payments of these ghost projects are given priority over genuine projects that are never paid at all.

(vii) Investigate the withdrawal of hundreds of Millions of shillings from undisclosed County accounts at Co-op Bank and KCB accounts by the following people who work under the Chief officer Finance that is; Silvester Amurono, Peter Kirui, Edward Odongo Konditty, Jacob Maiyo all who are accountants and staffs in finance department. Life style audit should be conducted as some of these officers have amassed huge wealth within a short time which doesn't match their legitimate income, for instance Peter Kirui an account clerk owning ploughing tractors and Silvester Amurono who has several real estate investments and others currently upcoming!

(viii) Investigate the use of the office of the Governor allocation that is virtually controlled and used to pay fictitious firms owned by the Chief officer Finance which including air ticketing companies, hire of VVIP cars whenever the Governor is travelling away.

(ix) Investigate why public money is transferred from County account to a private account in a Luo name where, were now the money is wired from that account to individuals close to the Governor. This account is suspected to being operated by one Edward Achola konditty an officer in the finance department.

(x) In October 2023 the office of the Governor was demolished for repairs hardly two years into existence and the work worth Kshs.35,000,000.00 (thirty five million) awarded to a contractor who was not competitively sourced. There was no advertisement for the job made, no bidders but of which the Head of Supplies was forced to work backwards by the Governor. This office had an occupational certificate from a certified structural engineer just a year ago; there was no condemnation certificate to warrant such.

Despite the incident being reported to the EACC and DCI in real time nothing was done.

The officers from Bungoma office could just come visit Governor's office and thereafter disappear.

The Investigations trail went cold despite obvious flaws that were not limited to lack of Engineer's condemnation certificate to demolish the office and lack of the Cabinet's approval for the office to be demolished.

(xi) Investigate the hiring of workers without the input of Public Service Board and the role of Justice Aggrey Muchelule who plays the role of a hatchet boy for Governor Barasa.

He was used as a conduit to bribe three Judges who heard and determined the County appeal case against the Public Service Board. He played a key role in transferring of the Judge who was handling the matter at Kakamega high court, Labor and employment relations court. Even Governor Barasa attended the wedding of Justice Muchelule, last year in Eldoret where he gave Kshs.1,000,000.00 (one million)

Justice Aggrey Muchelule was given Kshs.50, 000, 000.00 (fifty million) to ensure the County wins the case. It is the same justice Muchelule who influenced the transfer of the Judge who was initially handling the matter at Kakamega high court.

The circumstance under which the matter was handled is suspicious.

It's the same Justice Aggrey Muchelule whom the Governor used to stall the Ketraco case against the Governor despite the fact that the former EACC CEO Twalib Mbarak said that he had handed over a water tight case. Why is the case lying idle at the ODPP.

(xii) Investigate a DCI officer called Goeffrey Muhanda Mwera, who was previously stationed at DCI regional office Nyanza, this officer is the one normally used as the link between Governor Barasa with Justice Aggrey Muchelule in their corrupt deals, also he is the one who drafted a malicious petition to impeach Kakamega County public service board where his brother Denis Duncan Muhanda was made the petitioner, in return him and his brother received a reward of Kshs.6,000,000.00 (six million) and 3,000,000.00 (three million) respectively. It is alleged that Governor Barasa has manipulated the transfer of this officer back to Kakamega which is his home county and where he previously served for ten years so that he can help him execute such deals!

(xiii) Investigate the loss of Kshs.293,000,000.00 (two hundred and ninety-three million) meant for FLLoCA (Financing Local Led Climate Action) project that was flagged by world bank as

stolen thus causing the chief officer for finance Jeophita June Mwajuma to write a letter to National Treasury promising to pay the same in three installments.

The money was lost through companies that had not done any other service in the county; they were just formed specifically to loot this money. On discovery the sponsors indicated that they will stop funding any other project and wanted the money back.

At this point is when Chief Officer finance Jeophita Mwajuma wrote a letter to the treasury saying that they will pay back in three installments. CS treasury Hon. John Mbadi was then invited to Kakamega in the name of Inspecting Savona water project on 17th January, 2025 and corrupted with Kshs. 7,000,000.00 (seven million) for him to give green light for the county to continue with world bank projects.

Why did the CS treasury not order for the arrest of the companies that did the fictitious job and the county officials behind the scam. World bank money being a conditional grant, the recipient contributes certain agreed amount of which the recipient must deposit the agreed amount to the project account but what the chief officer finance Jeophita Mwajuma was doing under instructions of Governor Barasa is that she was putting money in the account and once it reflects for the world bank to approve the grant, she would withdraw the money immediately for their personal gain. When the chief officer concerned Mr. Msafiri Kuloba tried questioning he was fired for blowing the whistle.

(xiv) Investigate also why the money meant for climate change in the department of Environment was transferred to the department of water where Chief officer Mariam Were one of the Chief officers tasked to fundraise money for the Governor for 2027 election campaigns.

(xv) Investigate the following Chief officers: Mariam Were, Faith Gitira, Doreen Amwoga, Emmanuel Kariuki, Jeophita Mwajuma alias June, Shakir Adan, Dr Alila and former chief officers Leah Khasandi and Joshua Kutekha, and also CECM Mophat Mandela for their role as fundraisers.

These are the accomplices who have conspired to drain Kakamega County dry.

They are people of interest in the investigations; check their bank account transactions, Mpesa transactions, life style and properties which they have acquired since Governor Barasa assumed the office. Run their telephone conversation and investigate junior officers close to them because they are the ones they use mostly to transacting dubious deals with county funds.

(xvi) The following personal projects qualify to be listed as proceeds of crime, thus should be recovered by the state.

Both Governor Fernandez Barasa and Dr Alila are constructing high rise hostels in Bondo - Siaya County, twin plot hostels in Lurambi - Kakamega County.

Dr Alila is also constructing a high-end apartment in Sichirai market.

The same Dr. Alilah David took a huge loan from family bank as a cover up in case he is put to task to explain, does his salary qualify for such a huge loan?

Dr. David Alilah was also given a car make Subaru auto bac reg. no. KDC540B by some Somalis who supplies half empty boxes but paid full amount, this car should also be recovered by the state agency concerned.

(xvii) Investigate the Kshs.143,000,000.00 (one hundred and forty-three million) that was paid by Dr Alila to a company that supplied air in the medical department. In the last financial year. Another Kshs.43 million paid in the last financial year from department of Health for ghost work was paid and when the Assembly committee for Health attempted to investigate, they were quickly compromised.

(xviii) Investigate the Kshs.37,000,000.00 (thirty-seven million) splashed by County Government to renovate private Mumias Sugar Sports Complex field for the Governor's Cup from the ministry of social services.

This money was channeled through an event organizing company.

Another expenditure of interest is the purchase of attires used and also the Kshs.37,000,000.00 (thirty-seven million) paid to a local media with very limited viewership during last year Governor's cup

The expenditure above was not budgeted for but again why was public money thrown out to a private property if not a mission to steal public funds?

Because of laxity or complicity of investigative agencies or both to deal with reported crimes happening daily at the County, Barasa and June continue to milk the County dry.

(xix) During the investigations of fake fertilizer bought by Governor, for the farmers, the County CCIO was bribed by Governor Barasa to a tune of Kshs.300,000.00 (three hundred thousand shillings) the money was delivered to her by Chief Officer Emmanuel Kariuki.

It's notable that Mr. Kariuki boasted loudly that nothing will happen and true to his word, nothing has happened to date and nobody knows what became of the investigations.

The investigations died a natural death after that.

The CCIO of Kakamega should be a person of interest too.

(xx) Investigate the conflict of interest and nepotism where Governor Barasa's brother called Justus and his nephew called Fabian Musamiah were awarded contracts in the road department i.e;

a) Governor Barasa's brother and nephew

Project name: maintenance of Butali- Makhwabuye – Lutali pri- Wetesa- Ingavira road(11.9km) In Malava sub county

Contract sum: **Kshs.6, 317,465.00**

Contractor: **Manacom construction Co. ltd**

b) Governor Barasa Sister was also awarded a contract in the ministry of roads;

Project name: Maintenance of Makutano – Lwatingu, Malaika junction- Joyland, Joyland – Ola Road (5.4) in Lurambi Sub County.

Contract sum: **Kshs.3,229,440.00**

Contractor: **Faith Young enterprises ltd**

Contract Number: **1288185 – 2022/2023.**

(xxi) Investigate nepotism where through Governor Barasa's brother in- law George Wanjala was shortlisted for the position of Director Education support, county public service board shortlist Number 03 of 11/2023 where the interviews took place at Mumias Municipal officers.

Governor Barasa has also employed a sister to his last wife called SITIENEI in the county Liasson office in Nairobi.

(xxii) Investigate why contrary to laws and regulations through Governor Basara influence without the existence of the County Public Service Board nurses and clinical officers were recently recruited and appointed by chief officer Public Service one Priscah Otipa.

(xxiii) Investigate why contrary to laws and regulations through Governor Barasa influence, Chief Officer Public Service, Prisca Otipa without the existence of the County Public Service Board and without the involvement of the County Public Service board and in contravention of the law, irregularly advertised, shortlisted, interviewed and appointed people for the position of Data Clerks in the ministry of health.

(xxiv) Investigate why the case involving irregular hiring of drivers, clerical officers and other staffs under investigation by EACC Bungoma office has taken so long and may not materialize because your officers at Bungoma office have already dined with Governor Barasa and other senior staffs involved.

(xxv) Investigate why the case involving illegal and unprocedural appointment of Dr. Lawrence Omuhaka as the county secretary investigated by EACC Bungoma office has taken so long and may not materialize because EACC officers at Bungoma office have already dined with Governor Barasa. Dr. Omuhaka Lawrence appointment as the county secretary contravened the county secretary Act, the substantive county secretary Dr. Okoth was not removed from office as per the procedures laid in the county secretary's Act on county governments and as a result all cabinet decisions that have been made during the tenure Dr. Omuhaka Lawrence should be declared null and void.

(xxvi) Investigate why airtime for officers in Kakamega county is processed monthly and paid but then diverted to obtain cash money for personal gains. Officers received the airtime only once since Governor Barasa took office.

(xxvii) Governor Barasa has a safe build in his Harambee Home in Matungu subcounty where money is ferried to in bags and at times airlifted by a chopper from to Nairobi, this monies are proceeds of crime, raid his home and recover public funds stolen. It is believed that he has another safe housed in Nairobi in one of his houses.

(xxviii) Investigate the source of money used by Governor Barasa to recently acquire a high-end bullet proof black Prado car worth hundreds of million shillings.

(xxix) Investigate why chief officer finance renovated her office and the entire finance office at exorbitant figures without following any procurement process.

(xxx) Investigate why both the rear gate and the two-front gate of office of the Governor were demolished and new ones erected without following any procurement process.

(xxxi) Investigate the source of money used to furnish a private office for the first lady at Lurambi estate where office accessories were bought in cash to a tune of Kshs.50,000,000.00 (fifty million)

(xxxii) Investigate the source of money given to MCAs that move with the Governor every day, the MCA have abandoned their role of oversight and now they move with the Governor every

day wherever he goes, they receive Kshs.5,000.00 (five thousand shillings) each from the Governor every day.

(xxxiii) Investigate the bank statements and M-pesa transactions of the Governor aide/bodyguard an administration police officer by the name **Justus Wechuli**, it is believed that he is the one whom the governor does majority of his dubious transactions through him. Also investigate all the bank accounts and M-pesa accounts of the said bodyguard wife; he mostly transacts using his wife details

(xxxiv) Investigate the purported comprehensive medical cover of county staffs, why would a government procure a medical cover through a broker/proxy? The MTIBA thing is not working at all, staffs are spending personal money on their medical bills, interrogate staffs Moreso junior officers, why would a comprehensive medical cover have choices of hospitals, this is a big scam. There two proxies involved in the this Scam

(xxxv) Investigate why Governor Barasa moved the county main account from cooperative bank to Kenya Commercial bank, this has caused staffs salary delays as the agreement which had been made by the emeritus governor with cooperative bank to be paying staffs salaries as the bank awaits for disbursement was affected. Governor Barasa decision was motivated by kickback from KCB bank negotiated through his CECM Mophat Mandela.

(xxxvi) Investigate why the recently selection panel constituted for the appointment of County Public Service Board chairperson and members was not gazetted and was sworn in secretly and interviewed candidates for County Public Service Board vacancies without shortlisting of applicants!

(xxxvii) Investigate why millions of money is normally transferred from the county government to a specific staff a lady by gender who in turn withdraws the money in turns from M-pesa shops around and hands over the same to the first lady prof. Janet Kassily Barasa.

(xxxviii) Investigate the Matungu incident where Governor Barasa, Matungu area Member of Parliament and former CS Echesa Rashid clashed in a funeral on 8th February, 2025. Where a rowdy youth was captured by citizen TV news confessing that him with others were hired by Governor Barasa to cause havoc and main people in that funeral, up to date the Governor has not recorded any statement and no legal action has been taken against him, is he above the law? or has he corrupted his way out of the matter? The current CS interior was on record saying that the Governor must record a statement which has not happened up to date.

(xxxix) Every function Governor Barasa attends he normally lines up all the attendants and gives each kshs.200.00 (two hundred shilling what is the source of this money yet he is not paying county employees salary. This is a corrupt activity because this is not a campaign period!

(xxxx) Investigate the ten kilometers road projects per each ward, it is alleged that these roads are indeed not ten kilometers in reality yet they are paid as ten kilometers because the corrupt Governor Barasa ask for kickbacks of up to 40% from contractors.

(xxxxi) Investigate why Governor Barasa used contractors' payment certificates to get approvals and funds from the Controller of budget yet the same contractors have not yet been paid, where was the money diverted to?????

(xxxxxii) Investigate why some imprests, daily subsistence allowances and claim are voided in the system after being processed. Why should all approvals be done by chief officer finance and county secretary and not the chief officers of the user departments.

(xxxxxiii) Investigate why the budget allocated for the office of the Deputy Governor Ayub Savula was diverted and spend without the knowledge of the concerned officers, the deputy Governor is now operating from his pocket yet he had a budget allocated to his office.

(xxxxxiv) investigate why chief officer for finance usually spend budgets of other ministries without reference and approvals of the user ministries, despite the approved budgets allocations, the chief officer for finance singularly decides what the ministries gets.

(xxxxxv) investigate hot air contacts awarded in the names of planting trees to Governor Barasa bloggers calling themselves county oversight the likes of Juma alias Londiani FM of Tel 0704036417 and Francis Misiati alias Misiati wa misamiati of Tel 0715477293

(xxxxxvi) Investigate procurement of half empty boxes of drugs yet paid as full by chief officer medical services Dr. Alila David, these drugs are at time generic and a times these boxes are loaded with condoms.

(xxxxxvii) Investigate why Governor Barasa used contractors' certificates to gen funds from Controller of Budget yet the same contractors have not been paid up to date.

(xxxxxviii) investigate the link between county government of Kakamega and Farouk Kibet, on several occasions whenever the county receives the capitation, he flies in choppers from Wilson airport to Governor Barasa home in Matungu where he normally flies back to Nairobi with bags of money.

(xxxxxix) Investigate why some junior staffs almost six in number in the finance department receive monthly imprest of kshs.1,000,000.00 (one million) including the secretary and personal aide to chief officer for finance called Victoria Muswaili. What is the purpose of these imprests if not a conduit of embezzling public funds, how is this money normally accounted for?

(xxxxxx) Investigate why in the last supplementary budget ksh.700,000,000.00 (seven hundred million) was allocated in the ministry of agriculture for buying subsidized fertilizer and farm inputs that never happened!

(xxxxxi) Investigate the centralization of fuel and office stationaries yet each department has its own budget over the same, this is now is now controlled under finance department, it is actually a move aimed at embezzlement of public funds, even stalled cars are allocated fuel and stolen, always the government cars don't have fuel, insurance yet the same is budgeted and processed.

(xxxxxii) Investigate why the function of servicing, repairs and maintenance of government machineries, offices and equipment was moved from department of public service and administration to department of Finance, this is a clear move to steal public funds.

(xxxxxiii) Investigate why the function of air ticketing was moved from the department of transport to finance department, the main purpose was clearly to allow conflict of interest where companies aligned to chief officer finance June Mwajuma are the one offering the services.

(xxxxxiv) Investigate why servicing of government vehicles was moved from the dealer to internal public works department, a clear move to stall these vehicles so that they can be auctioned and as a result siphon the fuel made for the same since even government cars

auctioned last are still being processed fuel for and also the county public works does not have the qualified personnel to service this motor vehicle instead they hire some jua kali mechanics to do the servicing, this poses a risk to county staffs using this vehicle as these acts can lead to accidents.

(xxxxxv) Investigate why training of county staffs and Daily subsistence allowance is suspended verbally yet the is allocation for the same in the budget. These funds are normally processed and looted.

(xxxxxvi) Investigate why shortlisting of the long list for the appointments of county public service board was never done, interviews were conducted secretly and nominees' names have already been forwarded to the county assembly for vetting, a gross violation of the employment procedure in public service! Also, the as per the names and details of all the nominee it is clear that all of them are natives of Kakamega county yet the law provides for that 30% should be non-native, Moreso the nominee for the Chairperson position Mr. James Robert Wakungwi Sakwa is a village mate of the Governor, is this a family or clan affair?

(xxxxxvii) Investigate the high level of nepotism in county government of Kakamega where key and plum appointments goes to one clan the governor originates from i.e the speaker of the county assembly, the CECM agriculture, the CEO county microfinance, CECM roads and public works, Economic advisor, Chief officer public service, Chief of staff, CEO county revenue agency, Municipal manager Mumias municipality, Municipal manager Kakamega municipality, Majority leader of the county assembly, the nominee for the Chairperson county public service board, Chief officer fisheries, most chief officers, most contactors, most directors and heads of department are from one region of Kakamega county that is the southern region and specifically the "Wanga" Community that forms Mumias East sub county, Mumias West sub county and Matungu sub county, 90% of these are specifically from Mumias East where the governor originates..... is the county government of Kakamega a clan affair?

(xxxxxviii) Investigate the public participation funds, focus more on the surrenders counter check the surrenders. The surrenders are duplicates of each other, conduct people whose names are used to surrender to authenticate if indeed such purported public participations took place and if indeed the received the allowances? This is another major kitty used to loot public funds; funds are drawn every day from this kitty!

(xxxxxix) Investigate why ksh.70,000,000.00 (seventy million) allocated for Kakamega Teaching and Referral level six hospital for the financial year 2023/2024 was converted for personal gain, at first kshs.23,000,000.00 (twenty-three million) was withdrawn and converted for person gain then the remaining kshs.47,000,000.00 (forty-seven million) was also swindled leaving nothing for the hospital

(xxxxxx) Investigate why both the chief officer for finance Jeophita June Mwajuma and her secretary/ Personal assistant Victoria Muswaili doesn't have personal files in human resource department and if they have then their files are empty as they lack their academic, appointments, employment forms among other requisite documents yet they are is on the county payroll. There is need to scrutinize the entire county payroll.

(xxxxxxxi) Investigate the academic testimonials of all the chief officers, some chief officers are said to have presented academic testimonials of institutions which doesn't exist especially those who purported to have schooled out of the country, the same was not verified, those found with fake academic testimonials should be dealt with according to the law including refund of all public monies paid to them as salaries and allowances.

(xxxxxxxi) Investigate the source of funding for office of the first lady of Kakamega county?

(xxxxxxxi) Investigate why the supplier who supplied substandard fertilizer to the county government of Kakamega in the financial year 2023/2024 was paid despite the same fertilizer being under investigations?

(xxxxxxxi) Investigate the purported launching/flagging off essential drugs and non-pharmaceuticals to level two and three health facilities in Kakamega county worth Kshs.50,000,000.00 (fifty million) in Malava on 17th April,2025 by governor Barasa to the truth is that only one lorry that the governor opened was loaded with the purported essential drugs and non-pharmaceuticals which were not even drugs but water drips, gloves sterilization tapes and syringes collected from Matungu level four hospital, Butere level four hospital, and Malava level four hospital, the rest of the lorries were empty, why were they never opened for the public to view? Why hire lorries for display at the expense of the tax payer's money and loot the Ksh.50,000,000.00 (fifty million) meant for public drugs!

(xxxxxxxi) Investigate why Dr. David Anekeya Alila the chief officer health employed his biological sister called Damaris Alila at Butere level four hospital billing department? Dr. David Anekeya Alila is using his sister to steal medicines from this facility, once the doctors prescribe drugs for patients, she deliberately avoids to bill the medicines and drugs so that the patient is not given the drugs, once a big number of drugs is accumulated, they are sneaked out to a private pharmacy!

(xxxxxxxi) Investigate what consignment was moved from governor residence in Matungu on 18th April, 2025 at around 00200 hours at night in a lorry truck towards Kisumu direction!

(xxxxxxxi) Investigate the content of meeting that governor Barasa and Governor Jonathan Bii of Uasin Gishu held in Eldoret on 19th April, 2025 and then the two headed to Kilgoris the same day, what were they up to in Kilgoris

(xxxxxxxi) As county senior accountants we pose a question why did Governor Barasa appoint both the CECM for finance Mr. Benjamin Andama and chief officer finance Jeophita June Mwajuma both who have no any academic background in finance, if not a scheme to use their advantage of lack of knowledge in finance to loot public funds?????????

(xxxxxxxi) As senior county accountants we also pose another question, why is governor Barasa and chief officer finance using junior accountants on contracts term of employment in their financial deals and avoiding senior accountants on permanent terms of employment whom some are even CPAs if not mechanisms of looting public funds by exploiting these junior accountants lack of knowledge and experience on the consequences of misappropriation of public funds! These junior accountants have amassed wealth so fast to an extend that some of them have done very expensive weddings less than two years in employment for instance Mr. Allan Elijah Apwoka among others

Finally, Mr. Chairman, this is our final appeal to you that we as workers of Kakamega county hope that you will finally come to save Kakamega County from collapsing because it is already on its knees. The County Assembly of Kakamega is an appendage of the Governor.
